Stakeholder Engagement

We would like to take the opportunity to thank all who have engaged with the PLPAD Project so far. Since June 2017, the Project Manager has met with 450 individuals in face to face meetings, our PLPAD Stakeholder Event, attended two Mentor Conferences and a Student Conference.

July Stakeholder Event 1 at LSBU

We had a very successful 1st Stakeholder Event on Wednesday 19th July 2017, hosted by London South Bank University. 100 practice and academic staff attended. We welcomed representatives from the NMC, Canterbury Christ Church University and the Midlands Group of HEIs with whom we are collaborating.

Feedback on current Pan London PAD

Overall feedback is very positive from Event 1 and stakeholder engagement with groups. There is considerable support for a unified Pan London document, which helps give the PLPAD group a strong rationale for proposed new developments. We have received extensive feedback in relation to the current document and the range of feedback will help to inform the development of the new document—PLPAD 2.0.

Developing PLPAD 2.0 using the draft NMC standards and skills annexe

Feedback from stakeholders is to avoid assessment of skills being a tick box, time consuming and to promote a holistic assessment of skills. Professional values and the episode of care assessment are valued.

The NMC draft Education Framework proposes the roles of Practice Supervisors, Practice Assessors and Academic Assessors in relation to supporting and assessing students in practice. Our aim is to work with our stakeholders to have a unified approach Pan London.
