Since June 2017, the Project manager has met with 850 individuals in face to face meetings, including PLPAD October Stakeholder Event and various meetings and conferences in Trusts and HEIs.

October Stakeholder Event 2 at Camden Centre, Kings Cross

We held our 2nd Stakeholder Event on Monday 16th October 2017 and over 150 attended with representation from all ten HEIs and our practice partners from across London. We were particularly pleased to have 20 students from the HEIs involved in the project including students who had travelled from Guernsey. We were also joined by representatives from the Midlands Group of universities, the NMC and academic staff and students from Guernsey. The focus for the event was to work in groups and feedback on draft documentation including professional values, episodes of care, medicines management, skills and simulation. The groups provided us constructive and detailed feedback to enable us to develop the next stage of the document. Students commented below on the day.

Revised timeline from NMC

The NMC disseminated a letter to all HEIs NMC official correspondents with an updated timeline for the new standards.

The NMC have advised:

- There is insufficient time for the NMC to quality assure the programmes and therefore unable to approve programmes starting in September 2018 using the new standards. No HEIs across the 4 countries in the UK will be implementing the new standards as early adopters.

HEE London have been advised by the PLPLG and Project Manager that the proposed new NMC Education Framework will require further preparation for new roles. Pan London will develop and agree a unified approach to implementing the Education Framework. There may be some variation in the HEIs implementation of the roles, though principles will be agreed to ensure a unified Pan London approach.

The PLPLG at their meeting in November discussed the NMC revised timeline and agreed to continue with the original timeline to develop the new document. All HEIs will validate new curricula based on the new standards expected in April 2018.
