



Pan London e-PAD: Project Update

The implementation of the PL ePAD is progressing well and is building momentum. Working with MyKnowledgeMap (MKM), five HEIs have already implemented the ePAD for some of their pre-registration nursing programmes since September 2020. They have covered a significant geographical area and involved multiple NHS Trusts and Private and Independent sector organisations across health and social care. From September 2021 seven further HEIs will begin to implement the ePAD for their nursing cohorts.

Implementing the ePAD during a pandemic has not been an easy journey but thanks to the partnership between students, academics, practice staff and administrative staff an amazing accomplishment has been achieved.

Training for all staff has been regularly delivered throughout the year with each of the first five HEIs taking responsibility to facilitate sessions that were open to all practice partners.

The ePAD has been in use for several months and some great feedback has been received. Steve Malone of Guy's and St Thomas' NHS Foundation Trust, commented on how the new PAD being digital and multiplatformed increased usability and defined responsibilites "Implementing the ePAD has proven to be transformational for all users. By promoting ease of access through through innovative and intuitive technology, the ePAD has improved transparency, accountability and processes in supporting learners through their journey to qualification".

Adrian Palmer, Clinical Practice Facilitator at King's College Hospital NHS Foundation **Trust**, fed back that "The PLePAD system helps remind us to be more proactive regarding setting dates and helps to clarify the roles between Practice Supervisors and Assessors, by restricting what can be completed through different account permissions. helps smooth the assessment process. Having the outstanding placement listed on the dashboard has also made planning much easier."

Future Nurse Proficiencies

A number of students across London are currently undertaking their Part 3 PAD reflecting the Future Nurse standards. Through a number of discussions locally, London wide and via the pan England practice learning group it is evident that there are some challenges in achieving all of the proficiencies in practice. There are multiple factors that have impacted on this, some of which has been influenced by the pandemic, student placement opportunities and staffing issues.

PLPLG are engaging with practice partners to agree some short term, medium and longer term solutions to support student achievement and progression. Discussions are also occurring with HEE and the NMC to explore ways in which students can meet all requirements in line with the Standards for Student Supervision and Assessment in practice.

We will keep everyone posted on developments through local education meetings and local HEE events.
